❖ WHAT DOES THIS PRODUCT CONSIST OF?

❖ Type

It is a share class of LFIS Vision UCITS – Diversified Market Neutral, a sub-fund (Fund) of LFIS Vision UCITS, an investment fund in the form of a SICAV managed by LFIS Capital and domiciled in Luxembourg.

❖ Objectives

The Fund's investment objective is to seek stable returns with a low correlation to traditional markets and a target annualized volatility of between 5% and 10% under normal market conditions (it being understood that the annualized volatility realized by the Fund could be higher or lower). The investment policy of the Sub-Fund incorporates the consideration of certain ESG risks and characteristics through the application of investment filters seeking to restrict investments linked to certain industrial sectors including controversial weapons, tobacco and thermal coal.

To achieve this investment objective, the Sub-Fund will implement an investment policy seeking to capture implied premia linked to several implied parameters, dislocations and opportunities across different asset classes and implemented through long short positions. The universe of implied parameters includes (without limitation): volatilities, correlations, dividends, repo parameter. The asset classes to which the Fund will be directly or indirectly exposed include (without limitation): listed equities, private or public bonds (mainly "investment grade"), currencies of OECD countries and, to a lesser extent, of emerging countries. The Sub-Fund may also gain exposure to other UCITS eligible asset classes. The Sub-Fund's portfolio will be allocated to two sub-set of strategies in order to deliver recurrent uncorrelated returns over cycles. The allocation within each sub-set will evolve over time as a function of perceived market opportunities and risks.

The "carry" sub-set of strategy seeks to capture value and premiums from structural flows, regulatory dislocations, markets inefficiencies etc. affecting implied parameters across all asset classes; those strategies intend to deliver a structural positive carry over time. Within this "carry" sub-set of strategy, on an ancillary basis, cross-asset quantitative and systematic strategies with a "risk premia" approach could be deployed directly or through swaps. The "tail" sub-set of strategy seeks to generate gains in the case of volatile and/or adverse environment. It also aims to compensate in those cases the potential re-correlation on the downside of the strategies of the "carry" sub-set.

Each sub-set of strategies will be implemented by building long and short positions, through the use of eligible indices (i.e. that comply with article 9 of Grand Ducal Regulation of 8 February 2008, as may be amended from time to time, and CSSF circular 14/592 relating to ESMA guidelines on ETFs and other UCITS issues) and financial derivative instruments (such as equity futures, bond futures, credit default swaps, total return swaps, currency forwards, non-deliverable forwards, options, variance swaps, etc.), remaining always within the limits of the "Investment Restrictions" of the general part of the Prospectus.

If the Investment Manager deems it necessary for defensive purposes and on a temporary basis, the Sub-Fund may invest 100% of its net assets in short-term bonds, money market instruments, deposits, units or shares of money market UCIs or in cash.

❖ Targeted Investors

This product has been designed for investors who have an investment horizon of 3 to 5 years and who are willing to be exposed, in order to obtain a potential return, to a certain level of risk consistent with the synthetic risk indicator below.

❖ WHAT ARE THE RISKS AND WHAT COULD I GET OUT OF IT?

❖ Risk Indicators



The synthetic risk indicator makes it possible to assess the level of risk of this product compared to others. The risk indicator is based on the assumption that you keep the product for three years. It indicates the likelihood that the Fund will incur losses due to market developments. We have classified this Fund as a category 2 out of 7, which corresponds to a low risk category. The Fund is classified in this category in that it seeks to generate returns while limiting volatility.

❖ WHAT HAPPENS IF LFIS CAPITAL IS UNABLE TO MAKE THE PAYMENTS?

For your protection, the company's assets are held with a separate company, the Custodian. Therefore, the distribution capacity of the fund will not be affected in the event of the insolvency of BNP Paribas S.A. If the fund is dissolved or liquidated, the assets will be liquidated and you will receive an adequate portion of any proceeds, but you may lose all or part of your investment.

❖ HOW MUCH WILL THIS INVESTMENT COST ME?

The decrease in return shows the impact of the total costs you pay on the return you could get on your investment. Total costs include one-time, recurring, and incidental costs.

The amounts shown here are the cumulative costs related to the product itself, for three different holding periods. They include potential early exit penalties. The figures presented assume that you are investing EUR 10,000. These figures are estimates and may change in the future.
